



The timeline for the formation of BT

CONSTITUENT GROUPS



- max. 2 members-\$1 million or more



- max. 2 membersobligation in the amount of \$60.000 2 years



- max. 3 members-\$12,000 or more for last 2 years



- max. 2 members-\$4,000 or more for last 2 years



max. 1 member by the decision of the BT

- **5** years of experience in education



- max. 1 member

To be nominated for the BoT as Strategic Sponsor, the amount of donations to the School and/or Ayb Educational Foundation should exceed USD 1,000,000


Pursuant to these Regulations, if by the time of the next election scheduled to be conducted in 2 years, the donations made to the School and/or Ayb Educational Foundation by such sponsor exceed USD 1,000,000, such sponsor shall be entitled to be involved in this constituent group as a voting member



To be elected as a voting member in Grand Sponsor constituent group of the BoT, the candidates shall undertake to make donations to the structures of Ayb system (for the Ayb School) amounting to no less than USD 60,000 during the two years of the BoT's term of office.

The BoT shall take a separate decision regarding inclusion of each members to this constituent group. The financial obligations shall be a necessary but not the only qualification to become a voting member of the constituent group. The decision of the BoT shall not be subject to explanation or comment.

The liabilities shall be sealed by an agreement between the School and the member of Grand Sponsor constituent group. Pursuant to such agreement, the annual payment shall be done during the two weeks that precede each year of operation of the BoT. Therewith, the source of investment must never be credit and/or borrowed means both for the School and for the Grand Sponsor, while the assets must be allocated for the purposes of the School




To be appointed as a voting member of the Permanent Sponsor with Financial Obligations constituent group, such person's donation to the structures of Ayb system during last 2 years must amount to no less than USD 12,000.

The candidate nominated by the Permanent Sponsor with Financial Obligation constituent group shall undertake to donate no less than **USD** 12,000 during the BoT's two-year term of office.

To retain membership in the Permanent Sponsor with Financial Obligations constituent group, the members must continue making donations to the structures of Ayb system. Therewith, the amount of donations must be no less than **USD 15,000** during **two** years.

The financial obligation is fixed by the contract. For both the School and the sponsor, the financial source of the donation should not be credit and / or borrowed funds, and the funds should be directed to the statutory purposes of the School



To be appointed as a voting member of the Permanent Sponsor constituent group, the amount of donations made to the structures of Ayb system at the moment of election and for last 2 years must total no less than USD 4000.

To retain the seat of the voting member in the Permanent Sponsor constituent group, such member must continue making donations to the structures of Ayb system amounting to at least USD 5,000 during two years.

If the membership is retained, the financial obligation is fixed in the contract. For both the School and the sponsor, the financial source of the donation should not be credit and / or borrowed funds, and the funds should be directed to the statutory purposes of the School.

Strategist



To be appointed as Strategist, the candidates shall be nominated and elected by the newly formed BoT during **two** months after its formation.



To be nominated as Strategist, the candidate must have at least a five-year experience in the field of education and apply such experience for the development of the School..



To be nominated as Strategist, the candidate must have a clear vision for the School development, be motivated and inspired by the idea of education development.

The teachers of Ayb Elementary, Middle and High Schools, the heads of the Project-Based Learning club, homeroom teachers and class mentors shall be eligible to be elected to the Teaching Staff Representative constituent group.



To be nominated and elected as the BoT member in the Teaching Staff Representative constituent group, the candidate must be a teacher of Ayb Elementary, Middle or High School, or have at least a **ten-year** employment history in the field of education.


OF FORMATION

- Inclusion in the BT constituent groups as a voter on its own initiative and upon approval of the BT.
- Members/representatives of other governing bodies of the School shall not be eligible to be elected as BoT members. Other School employees, who are not members/representatives of the School's other governing bodies shall be eligible to be elected as BoT members.
- Until October 17, it is possible to Supplement the missing amount for a particular constituent group and join it as a voter
- If the candidate nominated for the BoT membership meets the requirements defined for more than one constituent group, he or she may participate as a voting member in each constituent group, however, as a candidate, he or she can opt for constituent group to be nominated in.
- The final composition of voting members for each constituent group shall be approved by the BoT.
- Candidates of each constituent groups may self-nominate or be nominated by any of the voters of the respective category from 22-27 October.



Constituent groups:


Strategic Donor, Grand Sponsor, Main donor with Financial Obligations, Continuous donor

OTHER REGULATIONS



- Each elected candidate shall confirm in writing the acceptance of all provisions of these Regulations and ethics clauses approved by the School's BoT by putting his or her signature to the bottom of a copy handed to him or her.
- The operating BoT shall approve the new BoT composition on the basis
 of the election results and the copies of these Regulations and ethics
 clauses signed by the candidates, as well as the donation agreements
 signed by the members of the constituent groups with financial
 obligation.
- The Regulations on the in-group election of constituent groups of the Board of Trustees of the Ayb Learning Hub shall be approved by the School BoT. Further amendments to this paper shall be made by the BoT.
- The candidates seeking both voting and non-voting seats on the Board of Trustees shall be notified that violation of any term, be that violation of the nomination or application submission term, shall make enrollment impossible. The decision of the BoT shall not be subject to appeal.
- The issues that cannot be settled by these Regulations shall be resolved in compliance with the School Charter and through decisions of the School Board of Trustees.
- Violation of the provisions of these Regulations and the ethics clauses, as well as the failure to fulfill obligations as a BoT member can result in exclusion of such member from the BoT.





OTHER REGULATIONS

- The designation of a 'donor' now signifies the collective engagement of both spouses in the community's affairs. With the donor's approval, their family is formally integrated into the community. During the election, donors have the option to indicate which spouse will stand for nomination or candidacy within any class group.
- In addition to the "Ayb" educational foundation, "Ayb" school and the central school of Dilijan, the "Identity and Values" platform was also included in the definition of the "Ayb" community. It is established by statement that donations to all structures of the system will be considered when compiling electoral lists.
